Re: Thomas Ramsey – a beachfront property owner – 305R Kings Highway

Dear Justice Brennan:

I was mailed paperwork including 1) a Notice of Acknowledgement and 2) a second document that I'll refer to simply as a 'SUMMONS'.

Not being an attorney I don't understand the particulars of either document. Nonetheless let me state I am normally confident that, in the end, common sense and justice will prevail.

Having said that I honestly feel my 'personal interests' have been ill served by both the Plaintiffs, as well as the elective representatives of the Town of Kennebunkport, in this matter.

First, as I understand it, a 'minority percentage' of beachfront property owners (aka the Plaintiffs) have been able to be the 'tail that wags the dog' insofar as their actions must now compel me, and other non-comitted beachfront owners, to accept their point-of-view as the right and reasonable one should they prevail?

Or, conversely, that the Town of Kennebunkport's Selectmen – and their interpretation of the question at hand – may instead prove to be correct? *When in fact I don't fully understand what the Town's representatives' exact point-of-view is?*

For example – why haven't the Selectmen addressed any type of busing ordinance that would limit (if not outright ban) hotels, motels, or condominium associations, now or in the future, from running any type of livery service to and from Goose Rocks Beach? And what, if any, plans do the Selectmen have for finally installing some decent public bathroom facilities for the public?

I appreciate a lovely summer day at GRB as much as anyone. And I have never endeavored to prohibit beachgoers from congregating in front of our home. I personally feel that, given the existing limited 'on street' parking program the 'status quo' system works fine – allowing beach access to the public. Even on the loveliest

of summer days by @ 5:30-6:00 PM the beach is all but vacant as families head off to dinner and their evening's activities etc.

My hope is that Justice Brennan sees fit to conclude that the current system works – and that his finding does NOT 'tip the scales' of beach usage towards the Plaintiff's point-of-view (at least as I understand it) and yet, by the same token, Justice Brennan's conclusion does not 'usurp' my family's ownership and use of a piece of land that is my home. A property, a beach, and a town I cherish. GRB is a special gathering place for my family and has been for decades.


Nonetheless I think the Selectman somewhat 'ignore' the beach property owners (waterfront or not), especially property owners who reside out-of-state.

But I do not think the Plaintiffs have been anymore forthcoming in declaring their full intent. And, at this point in time how does Justice Brennan expect property owners like me to pick 'the lesser of two evils'? Who should I side with and why?

IMPORTANT WARNING

IF YOU FAIL TO SERVE AN ANSWER WITHIN THE TIME STATED ABOVE, OR IF, AFTER YOU ANSWER, YOU FAIL TO APPEAR AT ANY TIME THE COURT NOTIFIES YOU TO DO SO, A JUDGMENT BY DEFAULT MAY BE ENTERED AGAINST YOU IN YOUR ABSENCE FOR THE MONEY DAMAGES OR OTHER RELIEF DEMANDED IN THE COMPLAINT.
